Northumberland County Council

Cllr Gibson reported on the recent West Committee meeting including "section 106" agreements. He also informed the Council that new rules governing his "Member's Allowance" means that grant aid will only be awarded for projects of £2,000 or more. Cllr Gibson invited questions from councillors.

01-05-11 **Roads**

Ward Lane. The traffic management protocol is for the empty forestry wagons to go up the Lane and full ones back through Wark. The road is in a terrible state and some of the passing places have been filled in and may have damaged drainage routes. At places there are no verges. The new kerb stones at the road end on B6320 appear to be very large and are possibly a danger to motor vehicles. Pot holes that were recently filled, didn't last very long.

There is a lot of concern about off-road motorcycles using the byways, BOATS and bridleways in the parish, often illegally. Clerk to contact the local police.

Assets Register
